# ARTICLE 18 GENERAL GOVERNMENT AND ADMINISTRATION CHAPTER 31 OPERATING BICYCLES, SCOOTERS, SKATES, SKATEBOARDS AND ANY ELECTRIC TRANSPORTATION DEVICE ON PUBLIC SIDEWALKS

Section 18-31 OPERATING BICYCLES, SCOOTERS, SKATES, SKATEBOARDS AND ANY ELECTRIC TRANSPORTATION DEVICE ON PUBLIC SIDEWALKS

The purpose of this ordinance is to limit the use of public sidewalks for walking only and to protect those citizens walking on public sidewalks in the town of West Union.

## 1. Enforcement:

- a. Examples Prohibited items on public sidewalks:
  - (1.) Bicycles
  - (2.) Scooters
  - (3.) Skates
  - (4.) Skateboards
  - (5.) Electronic Transportation Devices
  - (6.) Motorized Transportation Devices or Vehicles of any kind
- b. It shall be unlawful for any of the above-mentioned methods of transportation to be operated on public sidewalks in the Town of West Union.
- c. Reference SC statute 56-05-3430; Riding on Roadways and Bicycle Paths for bicycles being operated on the public roadway.
- 2. This ordinance does not pertain to any form of transportation for individuals who are handicapped.
- 3. The first offense is a \$100.00 fine: a Class I fine.
- 4. The second and subsequent offense is a \$200.00 fine: a Class II fine.

NOTE: This ordinance is authorized by S.C. Code 5-7-80.
